1. Tender must be accompanied by Earnest Money of Rs. 20,000/- (Rupees twenty thousand only) by way of Demand Draft, drawn on any Nationalized Bank in favour of 'ESI Account No. 1' Payable at New Delhi. Tender not accompanied by earnest money will not be considered. Please note that no interest will be paid to the firms against the deposit of Earnest Money. Earnest Money shall be refunded to the unsuccessful Tenderer only after the acceptance of Tender is conveyed to the successful tenderer.
2. Your rates should reach us on before 30.4.2009 upto 1 PM in the sealed envelopes and will be opened by the Tender Opening Committee on same day at 2 PM. Envelopes should subscribe the RATE ENQUIRY NUMBER 2/ESIH/Okhla and date of opening 30.4.2009 at 2 PM.
3. No figure or words should be overwritten or cutting in quotation. Rates should be written/printed on the letterhead of the company/firm in figure and words duly stamped and signed by the authorized person of the firm. Other terms and conditions along with all taxes should be mentioned clearly by the Agency.
4. The Rate should be quoted as on **(AS IS WHERE IS BASIS) on Company/Firm's letter.**
5. The successful tenderers will required to deposit the security deposit amount of Rs. 20,000/- (Rs. twenty thousand only)of the products value by way of demand draft/Banker's cheque drawn on any Nationalized bank in favour of ESI Account No. 1 payable at New Delhi. The security will remain valid for a period of sixty days and will be refunded only after the auction is finalized.
6. Rates quoted against this tender enquiry shall remain valid upto 90 days from the date of opening of tender. No request for change rates, if any, will be allowed or entertained during this period after opening of tenders by the Committee.
7. Any loss sustained by the Hospital as a result of non compliance of delivery schedule shall be recoverable from the tenderer and security deposit lying with this office may also be forfeited.
8. Conditional tenderers are liable to be rejected. In the event of acceptance Medical Superintendent's decision will be final. The rates should be quoted as per required specifications. The tender which is not as per our required specifications will not be considered at any ground.
9. Payment shall be made within one month from date of opening of tender through a Banker's cheque/demand draft drawn on any scheduled bank of India in favour of ESI Account No. 1, New Delhi after satisfactory acceptance. No condition/clause with regard to interest etc shall be entertained.
10. Tenderers responding to this enquiry shall be deemed to agreeable to the terms and conditions herein contained. These terms and conditions shall be binding on the successful tenderer.
