Sub: MBBS/BDS seats to be kept vacant in ESIC Medical/Dental Colleges - Compliance to interim orders of Hon'ble High Court of Kerala - reg.

Sir,

In continuation of this office letter dated 04/07/18 on the captioned subject, I am directed to convey that the Hon'ble HC of Kerala has allowed petitions in r/o **40** candidates where seats were not to be allotted but kept vacant vide interim order dated 14/06/18, pending disposal of the WPs. The details of the WP / candidates are as per **Annexure (05.07.18)**. The seats blocked for these candidates may be released for allotment and the candidates included in the list of eligible 'Wards of IPs for allotment of MBBS/BDS seats against 'Insured Persons Quota' following the Hon'ble High Court of Kerala allowing the petitions.

2. The Hon'ble HC of Kerala has also dismissed WP 18197/2018 covered under the interim order of 14/06/18, i.e. where seats were not to be allotted but kept vacant pending disposal of the WPs. The detail of the candidate is at Serial No. (41) of **Annexure (05.07.18)**. The candidate (Cert No. WPSRO4847) may not be considered as eligible 'Ward of IP' for allotment of MBBS/BDS seats against 'Insured Persons Quota' following dismissal of petition by the Hon'ble High Court of Kerala, and may be removed from the list of provisionally eligible candidates for allotment of MBBS/BDS seats in various ESIC Medical /Dental and some Government Medical Colleges against 'Insured Persons Quota'.
3. Accordingly, total of **73** seats (41 seats above + 32 seats vide letter of 04.07.18) out of the **103** seats blocked earlier in Round-1, stand released for allotment.


