Sub: MBBS/BDS seats to be kept vacant in ESIC Medical/Dental Colleges - Compliance to interim orders of Hon'ble High Court of Kerala - reg.

Sir,

In continuation of this office letter dated 20/06/18 and in supersession of this office letter dated 22/06/18 on the captioned subject, I am directed to convey that the Hon'ble HC of Kerala has dismissed petitions in r/o 32 candidates where seats were not to be allotted but kept vacant pending disposal of the WPs. The details of the WP / candidates after subsuming details as conveyed vide letter of 22/06/18 are as per **Annexure-I**.

- These 32 candidates as per Annexure-I may not be considered as eligible 'Wards of IPs' for allotment of MBBS/BDS seats against 'Insured Persons Quota' following dismissal of petitions by the Hon'ble High Court of Kerala. Their details may be removed from the list of provisionally eligible candidates for allotment of MBBS/BDS seats in various ESIC Medical /Dental and some Government Medical Colleges against 'Insured Persons Quota'.
- Accordingly, the **revised** details of MBBS/BDS seats to be kept vacant, i.e. **71 out of initial 103**, after dismissal of the WPs in r/o **32 candidates** (Annexure-I), in various ESIC Medical /Dental and some Government Medical Colleges against 'Insured Persons Quota', are as under:
