Subsequent to submission and verification of documents, if it is found that you are fulfilling the eligibility conditions for the post applied for, you shall be allowed to appear for the Interview for the said post (**purely on Provisional Basis**). The candidate being allowed to appear in the Interview will not mean that he/she has been declared eligible in all respects for the post. The eligibility of the candidate will be determined as per the eligibility criteria mentioned in the advertisement as well as according to the provisions of the Recruitment Regulations of the concerned post.
2. **If at any stage of recruitment process, it is found that the candidate is not fulfilling any of the eligibility conditions, ESI Corporation reserves the right to reject/cancel the candidature/selection/appointment of the said candidate.**
3. The candidates are being called on the basis of the information furnished by them in their application form.
4. **Before coming on the scheduled date and time as mentioned above, it is in the interest of the candidates to satisfy themselves that they are fulfilling all the eligibility conditions as mentioned in the advertisement uploaded on the website of ESI Corporation (www.esic.nic.in) for the above mentioned post.**
5. You are required to produce the following documents, **in original along with atleast one set of the attested photocopies:-**
 - a) Two latest passport size photographs.
 - b) School Certificate indicating date of birth.
 - c) Diploma/Degree/Post Graduate/Ph.D degree certificates, mark sheets of the examinations passed along with the attempt certificate.
 - d) Certificates/Documents in support of experience claimed, duly signed and stamped by Head of Institution/ Head of Department, clearly indicating the period with date, month & year of employment and the nature of work performed. Experience will be reckoned up to the last date of receipt of applications i.e. **24.01.2019**.

- e) Employed candidates will have to bring the No Objection Certificate (N.O.C.) from their employer(s).
 - f) Candidates belonging to reserved categories i.e SC/ST/OBC are required to bring the caste certificate issued in the prescribed format by the competent authority. The OBC certificate should be issued in the last one year with certificate regarding creamy layer.
 - g) Copies of publications/articles/research papers, if any.
 - h) The Medical qualifications possessed by the candidates should have the recognition of the Medical/Dental Council of India. The proof thereof may be attached.
 - i) In so far as Post-Graduation Medical qualifications awarded by Indian Universities are concerned, they should also find a place in the Schedules to Indian Medical Council Act, 1956, as amended from time to time. The proof thereof may be attached.
 - j) Holders of speciality Board of USA qualifications should complete the entire requirements of the Board concerned.
 - k) Completion of compulsory Rotating Internship Certificate, Registration Certificate, an official document showing name of College / Institution from where Degree / Diploma has been done and official document showing name of the University and College from where teaching experience has been attained is to be furnished.
 - l) The experience should be recognized by the Medical/Dental Council of India or the statutory body concerned with the system of medicine as valid teaching experience for teaching posts and certificate thereof or any other valid proof in support thereof should be submitted. Teaching experience in any other post like the post of General Duty Medical Officer / Medical Officer shall not be considered for eligibility purpose for recruitment to the teaching posts.
 - m) In the case of qualifications in Super-Specialties (M.Ch./ D.M.) except in the case of holders of D.M./M.Ch. of five years duration, the holders should have obtained M.D. (General Medicine) or M.S. (General surgery) or an equivalent qualification as prescribed by the said council in its recommendations on post graduate medical examination.
 - n) In the case of holder of D.M./ M.Ch. qualification of five years duration, the period of Senior Post Graduate residency rendered in the last part of the said D.M./ M.Ch. shall be counted towards requirement of experience.
6. No TA will be paid for the above purpose, nevertheless, out-station SC/ST candidates who are unemployed and are not in receipt of any kind of stipend/emoluments etc., will be reimbursed actual traveling expenses limited to 2nd Class Mail/Express Rail fare both ways by the shortest route subject to production of the original tickets. SC/ST candidates who are not permitted to appear in the interview for any reason will not be entitled to such reimbursement.

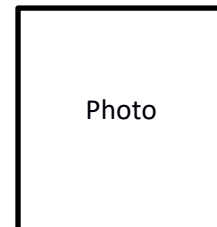
