**NOTICE**

**Sub:- Operation of Reserve panel / Waiting List for Recruitment to the post of MTS in Gujarat Region of Employees' State Insurance Corporation.**

The on-line written examination for recruitment to the post of MTS in Gujarat Region was held in the Month of March, 2016. On the basis of performance of on-line written examination, the list of total 88 candidates finding place in select list for recruitment to the post of MTS in Gujarat Region was declared on 05.01.2018. Out of those 88 candidates in the select list, 42 candidates did not report for document verification and some candidates submitted their unwillingness. Subsequently, the re-casted select list of total 88 candidates was declared on 19.06.2018 including the 11 candidates whose candidature were already cancelled vide notice dated 14.06.2018, as per Hqrs Office guidelines. Out of those 88 candidates in the re-casted select list, following 20 candidates did not report for document verification and some candidates submitted their unwillingness:-
