Invitation of proposal for providing Yoga Instructor in ESIC Hospital Ezhukone

Proposals are invited from reputed Yoga Centres / recognized non profit earning Yoga institutions/ relevant NGO s for providing Part time Yoga Instructors on contract basis for imparting yoga training to ESIC beneficiaries in this hospital on following terms and conditions

1..The Yoga Instructors should preferably possess the following qualification and experience

Qualification	Experience
A full time regular MA (Yoga) / M Sc (Yoga) from a Recognised University	Nil
OR	
Degree in Yoga from a Recognised University	Nil
OR	
Any time with full time regular one year Diploma in Yoga (after Degree) from a recognised University or an institute	One year (Professional Experience)

2.The institution will be responsible for providing qualified Yoga Instructors to ESIC Hospital Ezhukone.

No individual yoga instructor will be appointed. **ESIC will engage only with the institution for providing services of Yoga instructor.**

3.The Yoga instructor provided through these institutes shall perform duty for 3 hours per day for imparting Yoga Services on all working days. (ie. from Monday to Saturday).

4.**The monthly remuneration for each Yoga instructor will be Rs. 10000/- consolidated and the payment will be made directly to Yoga institutions/ NGO s engaged for providing the Yoga Instructor.**

5.Initially the Yoga Institutions / NGO s shall be engaged for one year, but can be extended on yearly basis upto three years..

Interested Yoga Institutions are requested to submit their application along with Biodata of Yoga Instructor to be provided to this hospital as well as experience of the institution in the relevant field latest by 22/11 /2018 up to 1.00 PM. Envelope containing the proposals will clearly mention “ Proposal for providing Yoga Instructor”

The Yoga Institutions / NGO s are required to make a presentation of their plan in this regard before a committee on 22/11 /2018 at 11.00 AM. No fee/ charges shall be paid for this presentation.

In case more than one tender is received, the institution / NGO with the higher Qualification and experience

will be preferred. In case more than one tender has the higher Qualification and experience(Yoga Instructor), then the selection of the institution/ NGO made based on the evaluation of the presentation of their plan.

The successful Yoga institution / NGO from this tender process, shall make an agreement in stamp paper with the ESIC Hospital Ezhukone, accepting the terms and conditions of this tender. Also an 6000/- shall be deposited as security deposit by the successful tenderer. The security deposit shall be payable by means of DD drawn in favour of ESI Fund account No. 1 payable at SBI keralapuram. The security deposit of successful tenderer will be refunded without interest on successful completion of contract period.

Any failure in the part of the institution / NGO/ Centre or the Yoga Instructor to provide the services as per the tender/ contract/ agreement , may be liable for forfeiture of the security deposit by ESIC.. The decision of the Medical Superintendent will be final and no appeal shall lie in this regard.

The Yoga Institution/ NGO s will be responsible for the compliance of various laws applicable in respect of engaging the Yoga instructor, including Labour laws,etc. **Disputes if any, shall be subject to the jurisdiction of court at Kollam.**

ESIC being statutory/ autonomous body formed under ESI Act,1948is bound by acts/ rules/ orders/instructions/ guidelines issued by Govt. of India/ ESIC Headquarters. Accordingly all such acts/ rules/ orders/ instructions/ guidelines wherever applicable shall form part of this Tender/ Contract.

The Medical Superintendent reserves the full right to terminate the engagement process assigning any reason and without any prior notice.
