The candidates have to attach the self-attested copies of all the relevant certificates/ testimonials on support of date of birth, category, sub-category i.e. educational qualification, teaching experience, Pension Payment Order (PPO), etc. with the application form and have to **produce originals thereof at the time of interview.**

**D. TERMS OF CONTRACT:**

The engagement will be for a period till the joining of regular incumbent. The contract would initially be for one year, to be extended for another one year on satisfactory performance, with a minimum term of one year in respect of teaching faculty.
