The above shortlisted candidates must bring the following Original documents in support of their eligibility criteria viz., Age/Educational/Technical/Professional/Experience /Caste etc., for the post concerned at the time of document verification along with **one set of self attested documents.**

1. Proof of Date of Birth (X<sup>th</sup>/Matriculation/SSC Certificate)
2. All Educational/Technical Qualification Certificates (along with marks memo's)
3. Professional qualification (G.N.M/B.Sc(Nursing)/Experience Certificate wherever required.
4. Registration Certificate with the Nursing Council.
5. Caste Certificate (SC/ST/OBC) issued by Appropriate Authority (In case of OBC category, latest OBC Certificate in prescribed Proforma along with Form of Declaration as appended & uploaded with select list as Annexure 'A' and Annexure 'B').-
6. Disability Certificate from competent authority in case of PWD.
7. Discharge Certificate in case of Ex-Serviceman.
8. Candidates seeking age relaxation as Govt. Employee/ESIC Employee will have to produce his/her Service Certificate from the present Employer.
9. The candidate already working in Govt. Service/ESIC Employee will have to produce 'No Objection Certificate' (NOC) from the present employer.
10. Two Passport Size Photographs.
11. Affidavit in case of mismatch in name/father's name/Surname etc., on various documents.
12. Photo Identity Certificate (Aadhar/Passport/Electoral Card/Driving License)
13. PAN Card.
14. Copy of Online Application Form.
15. Admit Card (Original)
16. Call letter for Document Verification in original.

**IMPORTANT NOTE:-**

1. While utmost care has been taken for preparing the list of provisionally eligible candidates for Document Verification, however inadvertent human errors cannot be overruled.
