On the basis of clarification dated 25.07.2017, from issuing Authority of Experience Certificate, refers that Plaster and other orthopedic related job roles are performed by Operating Room Assistant . Thus, the candidate is not eligible as per RRs framed for the post of Dresser. Hence, the candidature has been cancelled.
2	22232180312	BHAGWAN SAHAY MEENA DOB-06.07.1989 NURSING ORDERLY	ST	The hospital is not found in the approved list of hospital during the acquired experience period from Government of Rajasthan. The hospital was registered from District industries Centre Madhopur, which is not in order. Thus, the candidate is not eligible as per RRs framed for the post of Nursing Orderly. Hence, the candidature has been cancelled.

4	22210010469	PHILOMINA REGGIE DOB-21.12.1991 STAFF NURSE	UR/ PWD	The candidate applied the PWD disability under OL but during document verification, she submitted PWD certificate which shows as "post burn scarring and partial amputation left hand with scarring fact and scalp "and disability mentioned as HEAD AND LEFT UPPER LIMB". As per RRs of Staff Nurse having OL disability candidate is eligible for the post of Staff Nurse. Thus, the candidate is not eligible as per RRs framed for the post of Staff Nurse. Hence, the candidature has been cancelled.
