PART TIME SUPER SPECIALIST

7. The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
8. Selected Candidate will join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued, failing which the offer letter will be treated as cancelled.
9. Part time Super Specialist has to wear his/her own white coat with name badge during the duty hours.
10. He/ She will be required to mark attendance manually as well as in BAS(Aadhar Based Biometric attendance System)
11. Candidates are requested to bring their original certificate in evidence of age proof (Date of Birth), Educational qualifications, Medical Council registration of the State/MCI, Experience certificate along with one set of self attested Xerox copies with 2 passport size recent photographs for appearing in the walk-in interview without fail.
12. Draft for interview fee (Interview fee of Rs.200/- in favour of **ESI Fund A/C No.1** payable at Chennai (By Demand Draft) for all except candidates belongs to SC/ST/WOMEN/PWD Category.

FOR CHILD PSYCHOLOGIST (FULL TIME)

1. The Age limit between 21 -35 years of age. However, maximum age may be relaxed up to 40 years if the candidates are having higher qualifications and experiences.
2. The Offer of appointment is purely on contractual basis for a period of one year from the date of joining with no right to be absorbed in the organization.
3. The appointing authority reserves the right to terminate the appointee anytime even before the tenure without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period. The appointee at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
4. The appointment is subject to Medical Fitness. The candidate, if selected will be required to submit acceptance/consent letter in writing before appearing for Medical examination.
5. No TA/DA will be admissible for attending the interview/joining the post.
6. You will be required to perform such other work as may be needed in the legitimate interest of patient care in the Hospital.
7. Selected Candidate will join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued, failing which the offer letter will be treated as cancelled.
