## ESI Scheme in India

The employees drawing wages up to Rs. 15,000/- a month are entitled to health insurance cover and other benefits, under the ESI Act. The Act now applies to over 7.23 lakh factories and establishments across the country, benefiting about 2.03 crores family units of workers. As of now, the total beneficiary population of ESI Scheme stands over 7.89 crores. Ever since its inception in 1952, the ESI Corporation has, so far, set up 151 Hospitals, 1418/140 Dispensaries / ISM Units, 812 Branch/Pay Offices and 61 Regional & Sub-Regional/Divisional Offices.

ESI health scheme, India's largest multidimensional insurance scheme with the largest medical infrastructure is persistently working to improve health care services to its insured persons.
